

Welfare Schemes For The Farmers

Mandi Parishad has started various Welfare Schemes for the development programmes of the New Mandi Areas & Places keeping in mind the benefit of the Farmers.

Public Grouped Individual Accident Help Scheme:

In the listed Areas of Uttar Pradesh labours, Agricultural labours, Mandi Samiti's/Parishad's workers who are active in farming, in the operation of agricultural equipments, they are in the operation of agricultural, electronic equipments or they are involve in the well construction & related works or if they get injured in while using tractor for thrashing/loading agricultural produces & as a result if there is any injury/limb loss or death then there is a provision of compensation to be given by Mandi Parishad through Mandi Samiti & concerned Sub District Magistrate.

(a) Region of The Scheme:

Acceptable application forms under this scheme shall be for limb loss/ death or loss of eye sight while doing agricultural work or other related work only. The region of this scheme is Uttar Pradesh only. All the Farmers/Agricultural Workers or the workers of Mandi Parishad who were injured during an agricultural work or in the main market of Mandi Parishad(Haat Yard/Sub Bazaar/Sub yard) where food supply or other related work shall come under the cover of this scheme.

(b) Period:

From date 01.07.2005.

(c) Rules & Regulations:

- 1 The acceptable age limit under this scheme is between 18 to 60 years.
This scheme is applicable to the residents/farmers/agricultural or Mandi labours of Uttar Pradesh only. The area of accident should also be Uttar Pradesh only. In any other region's farmer/labour is residing in Uttar Pradesh for past two years & this has been approved by Tahsildaar, then he may be secured under this scheme.
As it is clear with the definition of an accident using Agricultural Equipments/ Agricultural Chemicals/Bullock cart/Tractor/Trolley for
- 3 agricultural or related works only & to be hit by a cow or bull or due to any fatal insect bite in the farm etc come under the external reasons of mishap & shall be insured under this category.
In the case of a limb loss in an accident, at least a medical treatment certificate is required from the nearest First Aid Centre or from a
- 4 Government Hospital. The coloured photograph of the damaged limb with the application attested by at least two relatives of the claimant. In the case of death the post mortem certificate is required.

Damage done to the body intentionally/suicide attempt/ any mishap in drunk state/ mishap by indulging in any fight or so or during any wrights/flood/earthquake/ fight/atomic waves etc or if any damage done for personal fights or any legal punishment do not come under the cover of this scheme. These claims shall never be completed.

6 Details of Financial Help:

(a)	Accidental Death	Rs.2,00,000/-
(b)	Loss of both legs/hands or eyes or loss of any two limbs	Rs.60,000/-
(c)	Loss of one leg/hand or eye	Rs. 30,000/-
(d)	Loss of four fingers together of a hand	Rs. 28,000/-
(e)	Loss of three fingers together of a hand	Rs. 20,000/-
(f)	Loss of two fingers together of a hand	Rs. 12,000/-
(g)	Loss of Thumb	Rs. 18,000/-
(h)	Loss of Small Finger	Rs. 3000/-
